- You will get pay at the minimum of BPS-11 including usual allowances as admissible under the rules. You will also be entitled to annual increment as per existing policy;
- ii) You shall be governed by the Khyber Pakhtunkhwa Civil Servants Act 1973 and all the laws applicable to the Civil Servants and the Rules made there-under;
- iii) You shall be on probation for a period of one year, in terms of Section 6(2) of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 15(1) of Khyber Pakhtunkhwa Civil Servants (appointment, Promotion & Transfer) Rules, 1989 and extendable for another year with the specific orders of appointing authority within two months of the expiry of first year of probation period as specified in Rule-15(2) of Rules ibid.
- iv) In case you wish to resign at any time, fourteen days notice shall be necessary or in lieu thereof fourteen days pay shall be forfeited;
- v) Production of medical certificate of fitness from Medical Superintendent, Civil Hospital Peshawar and character certificate from two gazetted officers;
- vi) Your retention in service shall be subject to verification of your domicile, testimonials and antecedents etc. from the concerned authorities/offices;
- vii) Your appointment is liable to be terminated at any time without assigning any reason before the expiry of the period of probation/extended period of probation, if your performance during this period is not found satisfactory;
- viii) You will join duty at your own expenses, as no TA/DA shall be admissib there-for:
